Summary

At the January 9th goal setting session, the Council brainstormed a list of items they would like to work on in 2021. The Council has identified 20 projects for 2021, which is not attainable given time and resources. Ideally, the Council would identify their top three to five priorities to focus on for the upcoming year.

Council Action

Before the work session, each Councilmember should look at each item and decide whether it's a goal for 2021, 2022, 2023 or if it should be deleted. For 2021 goals, the items should be ranked by highest priority (#1) to lowest priority (#5). If possible, please email rankings to the City Manager before the work session. The Council will spend most of the work session sharing their priorities so that the list of 2021 Objectives can be refined.

Full Description

At the January 9th goal setting session, the Council brainstormed a list of items they would like to work on in 2021. At the end of the session, each Councilmember was assigned a community priority to further refine the goals under that category.

The draft list of the City of Excelsior 2021 Objectives is included in the packet. There are three categories of projects:

- Community Priorities the four categories the Council discussed at the strategy session
 - 1. Enhance the Small Town
 - 2. Fiscal Management
 - 3. Legislation and Policy
 - 4. Clear and Timely Communications
- 2021 Projects significant projects that are expected to be completed in 2021
- Pending Projects items that staff is monitoring

The last two categories have been added to the list of objectives so that staff can utilize this document during their 'team meetings', which occur every other month. Staff uses the team

meetings to discuss progress made on Council goals, current projects, and any other items that involve multiple departments. At the end of each team meeting, the Council will be sent the list of objectives with notes regarding the status of each item.

The Council has identified 20 projects for 2021, which is not attainable given time and resources. Ideally, the Council would identify their top three to five priorities to focus on for the upcoming year. If the priorities are completed before the end of the year, the Council would select which item(s) to focus on next. If the Council identifies new top priorities throughout the year, the Council would then need to decide which existing top priority should be delayed.

In addition to the items the Council discussed during their goal setting session, there are several items that the Council identified as potential projects but are currently not included in the list of 2021 objectives. The status of the 2020 objectives and whether they are currently included in the 2021 objectives is included in the packet.

To help the Council identify their top three to five priorities for 2021, staff has created a worksheet for each Councilmember to identify whether the project should be completed in 2021, 2022, 2023 or deleted. The list includes 20 projects identified by the Council during the goal setting session, 10 uncompleted goals from 2020, and 5 miscellaneous items.
